## **County of Santa Clara Office of Supportive Housing Extends Inclement Weather Episode through Sunday, March 4th**

*Additional shelter beds are available*

**Santa Clara County, CA:** The Office of Supportive Housing is extending the Eighth Inclement Weather Episode for all of Santa Clara County until Sunday morning, March 4th, 2018 and for the City of Gilroy until Monday morning, March 5th.

### **ABOUT INCLEMENT WEATHER EPISODES**

During extreme cold temperatures that warrant a declaration of inclement weather, the County's Office of Supportive Housing implements the Inclement Weather Plan which supplements the regular, ongoing cold weather shelter program. In December 2017, the County's Office of Supportive Housing raised by several degrees the trigger temperatures for an inclement weather episode from previous seasons.

The current trigger conditions are as follows:

- There is a forecasted overnight low of 40 degrees (previously 38 degrees) or lower with a probability of rain of less than 50%; or,
- There is a forecasted overnight low of 45 degrees (previously 42 degrees) or lower with a probability of rain of 50% or greater.

These conditions are less severe than conditions that would trigger the State to declare a state of emergency; however, they can present significant risk to unsheltered homeless persons, especially those who are ill or injured.
